2006 Optional Tax Tables

If your taxable income is \$50,000 or more, you cannot use Form 140A to file for 2006. In this case, you must file using Form 140.

To Find Your Tax: Read down the income column until you find your taxable income shown on Form 140A, line 21. Read across until you find your filing status as shown on Form 140A. Enter the tax on Form 140A, line 22.

Example: Mr. and Mrs. Timely are filing a joint return. Their taxable income on Form 140A, line 21 is \$19,360. First, they find the \$19,350-\$19,400 income line. Next they find the column for married filing jointly and read down the column. The amount shown where the income lines and filing status column meet is \$529. 
