

2002 Optional Tax Tables

To Find Your Tax: Read down the income column until you find your taxable income shown on Form 140, line 19. Read across until you find your filing status as shown on Form 140. Enter the tax on Form 140, line 20.

<p>Example: Mr. and Mrs. Timely are filing a joint return. Their taxable income on Form 140, line 19, is \$19,360. First, they find the \$19,350-\$19,400 income line. Next they find the column for married filing jointly and read down the column. The amount shown where the income lines and filing status column meet is \$556. 
