All extension requests must be postmarked on or before the original due date of the return, unless the original due date falls on a Saturday, Sunday, or legal holiday. In that case, your request must be postmarked on or before the business day following that Saturday, Sunday, or legal holiday.

If you are a calendar year filer, your request for a 2007 filing extension must be postmarked on or before April 15, 2008.

An Arizona extension cannot be granted for more than six months beyond the original due date of the return. Arizona will accept a valid federal extension for the period covered by the federal extension. This includes the automatic six month federal extension.
