**Purpose of Form**

The common parent of an affiliated group that files a federal consolidated return may elect to file an Arizona consolidated return. The election by the common parent is effective only if it is accompanied by written consents to the election signed by each of the members of the affiliated group. This form is used by each of the subsidiary corporations included in the affiliated group to consent to the election made by the common parent. The consent form must be signed by a current officer of each subsidiary in the affiliated group.

**NOTE:** Refer to ARS § 43-947 and the Form 120 instructions for further information regarding the election to file an Arizona consolidated return.

**Elections for Taxable Years Beginning From and After  
December 31, 1993**

The election must be made by the common parent on or before the due date, including any extensions, for filing the original return (Form 120). The completed Forms 122 must be attached to the Form 120 filed with the department for the first taxable year a consolidated return is filed. The consent form must be signed by a current officer of each subsidiary in the affiliated group.

**How to Make an Election to File an Arizona  
Consolidated Return**

- Complete a separate Form 122 for each subsidiary included in the federal affiliated group for the taxable year for which the election is made. The Form 122 for each subsidiary must be signed by a current officer of that subsidiary.
- File all of the completed Forms 122 (for each subsidiary included in the federal affiliated group) AND the tax return by the due date, including extensions, for filing the original return.
